Infrastrutture S.p.A. (IFT), (www.infrastrutture.eu), is an integrated Independent Power Producer (IPP), the industrial owner of a group of asset companies, dedicated to environment and renewable energy. IFT IS a pioneer investor in renewables, and active in power for over 50 years as developer, investor and owner in energy production. Led by Pier Francesco Rimbotti, the Company is also a leading actor in providing technical, commercial, financial, asset management and O&M services to partners and major corporations. The Group holds a most significant track record, having participated in the development of over 2.0 GW, of which 400 MW as principal sponsor in the renewable energy sector, focused on wind photovoltaic, hydro and biomass technologies. Through an investee company has provided O&M services for over 400 MW. In Italy Infrastrutture has realized a portfolio of 8 photovoltaic plants. Currently, the Group owns and managers a photovoltaic portfolio in Lombardy. In recent years the Group joined in biomethane production sector with 10 projects in development and 1 in construction. It is active internationally, where it has contributed to the development of over 5.000 MW through a network of partners in energy and finance built over years of successful presence in the market. Infrastrutture S.p.A. invests actively in new technologies, and is very active in the area of “Research & Development” to support its’ own long-term investments and that of its’ customers. Since 2012 has been present in Japan developing solar and wind projects and has formed a joint venture for management and O&M services. Particularly in Japan, the Group has already developed about 90 MW of solar projects, some of which in operation and others under construction and is developing a further pipeline of 500 MW of wind projects. From 2017 the Group is also active in Latin America where through joint ventures is developing a pipeline of solar projects of over 1,2 GW. The Group, supported by a Management and Staff with decades of specific expertise in technical and financial areas, based in the offices of Milan, Rovereto (TN), Florence, Bogotà, Santiago de Chile, and Tokyo.
